## 1. APPLICATION FEES (PER STUDENT)

The following fees are due for each student enrolled at the LFZ:

- + New Student: **CHF 1,000.-**, non-refundable;
- + Student already enrolled at LFZ the previous year: **CHF 250.-**, non-refundable.

## 2. SECURITY DEPOSIT AND FEE OF FIRST REGISTRATION

A refundable security deposit of **CHF 4'000.-** (hereafter: the Security Deposit) is required from each family to become a member of the ALFZ and, thus, be able to send their children to school at LFZ. Security deposits are requested upon confirmation of enrolment and must be paid before the start of the school year or, for enrolments during the year, according to the schedule stated in the confirmation of enrolment.

Any payment made to LFZ is first allocated to payment of the Security Deposit.

Any unpaid amounts will be deducted from the Security Deposit before it is refunded.

Deposits will be refunded to all families whose children are no longer enrolled at LFZ within two months after receipt of their written request. The refund will be sent to the original payer (parents or company). No refunds may be made to persons/entities other than the original payer, regardless of the billing address and the responsibilities for tuition fees.

An admission fee of **CHF 1,250.-** (non-refundable at the end of schooling) will be charged for each new student enrolled for the first time at LFZ. This is in addition to tuition fees and the application fee. Students who return to LFZ after a period of absence are not asked to pay this admission fee again.

## 3. ANNUAL TUITION FEES (regular rates, applicable to assisted families and businesses)

- + **Maternelle - Kindergarten (PS, MS, GS): CHF 18'377.-**, intended to cover the operating expenses of the year and the real estate cost;
- + **Elémentaire - Elementary (CP, CE1, CE2, CM1, CM2): CHF 16'451.-**, intended to cover the operating expenses of the year and the real estate cost;
- + **Collège - Middle school (6<sup>th</sup>, 5<sup>th</sup>, 4<sup>th</sup>, 3<sup>rd</sup>) CHF 22,208.-**, intended to cover operating expenses of the year and the real estate cost;
- + **Lycée - High school (2<sup>nde</sup>, 1<sup>st</sup>, Terminale) CHF 26,623.-**, intended to cover the operating expenses of the year and the real estate cost.

## 4. REDUCTIONS IN ANNUAL TUITION

### 4.1. Reductions are only applicable for families who pay their school fees and receive no support from their employer.

The ALFZ grants, on request and subject to conditions, reductions on tuition:

- + To families who do not receive assistance from their employer for the payment of tuition fees;
- + To families with one, two or more children attending LFZ;
- + To families whose annual income is less than CHF 210'000.- according to the Swiss income of the Salary Certificate (*Lohnausweis*) for the calendar year preceding the school year, line 11 for the Canton of Zurich; for families unable to provide this document and/or families arriving during the year, a theoretical calculation of the family's annual income will be done, with this calculation taking into account the Swiss income prorated over one year as well as, possibly, the income of the spouse domiciled abroad, any special request being submitted to the reduced rates committee;

- + To students enrolled at the LFZ for the sixth consecutive year, only for families not assisted by companies with payment of their school fees for the year concerned, reduction applicable per child concerned, the amount of which could be revised within the budget and resources of the Association.

#### **4.2. Request for reduced fee**

A reduced fee shall not be granted automatically. To benefit from a reduced fee, families must expressly submit a request for a reduced fee according to the procedures specified for this purpose by LFZ in its financial terms and provide the required supporting documents, within the deadlines indicated for this purpose. It is strictly mandatory to comply with these conditions and the deadlines.

Reduced fees are only valid for one year. Requests must be renewed each school year within the timeframes specified for this purpose and must be accompanied by new supporting documents relating to the year concerned.

Families wishing to apply for a reduced fee are required to strictly observe the terms and conditions stated in the “financial conditions” document of LFZ, adopted by the Management Committee.
